SUPPLEMENTAL STATEMENT

In order for this Court to be fully informed in its conferencing of this appeal, appellees note an appeal to this Court from a final judgment of the Sixth Circuit striking down another state statute which burdened access to abortion services. *State of Ohio v. Akron Center for Reproductive Health, et al.* (No. 88-805) appeals a holding that an Ohio statute requiring notification to parents of minors' abortions is unconstitutional. The Jurisdictional Statement was filed on or about November 14, 1988, and a responding motion is due January 13, 1989. Some of the attorneys in the instant case are counsel for appellees in *Akron Center*.

Additionally, appellees note that in *Hodgson v. Minnesota*, 853 F.2d 1452 (8th Cir. 1988), a case in which the Eighth Circuit Court of Appeals upheld in part and invalidated in part a Minnesota statute also requiring parental notification, the parties have been granted until January 5, 1989 to petition for certiorari or appeal. Although another case involving restrictions on access to abortion, *Turnock v. Ragsdale* (No. 88-790), is also on appeal to this Court (responding motion due January 14, 1989), it involves only a preliminary injunction by the Circuit Court and would appear to be inappropriate for review at this time.
